**May 12, 2015 FINAL Meeting Minutes**

I. Call to Order

Anne Goslin called the meeting to order at 7:10 p.m.

II. Approval of Minutes

Barry Hersh made a motion to approve the April 10, 2015 minutes. The motion was seconded by Rebecca Shannonhouse. All approved the minutes.

III. Old Business

A. Hoyt Barnum House

HPAC is waiting for a response to its suggestion that the Historical Society and City enter an agreement, by way of a memorandum of understanding, regarding the logistics, financial aspects, and preservation of the potential house move.

B. Sacred Heart

HPAC is waiting to hear from the City regarding making the cottages available to the public. Wes Haynes of Historic Neighborhood Preservation (HNP) will encourage the City to prioritize the stabilization of the barn and carriage house.

C. Programming

1. Barry Hersh reported that he attended a planning meeting regarding the celebration of the city's 375<sup>th</sup> birthday. Commemorative ideas include: developing an app for touring historic places, a party at Old Town Hall, and a timeline of the city's history. Ideas are still being solicited.
2. Program ideas were discussed. Barry Hersh will look for potential developers who have successfully re-adapted old buildings to make a presentation that will be followed a panel discussion.

3. 9 Hobbie Street: Anne Goslin offered to reach out to the Cove Neighborhood Association to determine the neighbors' feelings on the proposed demo.

Wes Haynes informed the committee that the state has issued an RFP for a historic resources survey of counties impacted by Hurricane Sandy. He suggested that both HPAC and HNP inquire about the survey's Stamford scope.
