

The Commissioners met with a full quorum; Chairman Green called the meeting to order at 5:10 p.m.

Minutes of May 22, 2014 approved:

Commissioner Weinberg made motion to accept the minutes and Commissioner Granser second the request to approve the minutes. Minutes approved unanimously.

Item # 1: Request: To create the Classification and one (1) position of Special Projects Coordinator Youth Employment

Terri Drew discussed the re-organization of the Mayor's Youth Service Department. Request made for the creation of a full time Projects Coordinator Position. Currently, this position is a seasonal part-time position. The full- time position will encompass and expand the duties for year round projects.

After a considerable amount of discussion by the Commissioners, Commissioner Weinberg moved to approve and Commission Teichman moved to second the approval. Position approved for: Projects Coordinator at the hourly rate of: \$25.97 to 30.67.

Item # 2: Request: To create one (1) position - Senior Paralegal position with the Office of Legal Affairs Department.

Katheryn Emmet, appeared before the Commissioners to request an elimination of one (1) Paralegal position, and thereby replacing it with: Senior Paralegal at a V13 level.

Currently in this position is a Paralegal and the individual has been working outside her job description and performing the duties of a Senior Paralegal. Counselor specifically noted that the Legal Department has approved the funding in their budget and can accommodate this promotion.

After discussion, with one abstention, Commissioner Granser moved to approve the request and Commissioner Nanos seconded the motion to approve the position of Senior Para Legal at a V13 level, at a salary of \$65,806 to \$77,725.

Two requests made from Chairman Green:

1. Request to review the City's overall promotional policy.
2. Request to review City Vehicles list

Clemon Williams agreed to provide this information to Chairman Green.
