

Item #1: Approval of Minutes for previous meeting of: June 25, 2015:

Commissioner Weinberg requested a change to the minutes: Request noted by Mr. Williams for change to be made by the recording secretary L. Cavaliero. Commissioners agreed on unanimous approval of the June 25, 2015 minutes with the changes to be made.

Item # 2: Advanced Starting Rate of Pay for: BUREAU CHIEF -- TRANSPORTATION TRAFFIC and PARKING:

Director, Williams presented the Commissioners with a salary guide for their review that reflected detailed information on the salary ranges from surrounding towns and cities for the position of Director of Transportation.

Mr. Pollard provided the Commissioners with an overview of the extensive requirements needed for the position. An Interview Committee met with all the candidates. They made their final choice of a candidate based on the incumbent's background, experience and education; coupled with his vision for the present and future for the City of Stamford.

The Commissioners unanimously voted to approve the advanced pay rate of Pay Plan – Grade 6 - \$139,458.
