In-Person and Web Meeting Rules:

This is a regular Public Meeting of the Planning Board. Members of the public may observe the meeting but will not be permitted to participate during this work session. Public testimony is encouraged during the public comment period at the Public Hearings on the adoption of the Comprehensive Plan to be held over two sessions: September 9, 2025 (virtual) and September 16, 2025 (virtual and in-person).

The purpose of the August 12, 2025 Public Meeting is for the Planning Board to have a work session on the Comprehensive Plan. The [Connecticut General Statutes](#) require the Planning Board to prepare or amend and adopt a plan for the municipality. This work session ensures Board members are well-versed in the contents of the plan and find the recommendations meet the requirements of the Charter and General Statutes, which aim to “promote with the greatest efficiency and economy, the coordinated development of the City and the general welfare, health and safety of its people.” ([Sec. C6-30-3](#))

If necessary, to maintain orderly conduct and compliance with meeting protocols, Planning Board members and staff will take actions to ensure the meeting proceeds in accordance with the agenda. A Chair of a public agency has authority to address disruptions caused by members of the public during meetings. To that end, the Chair will repeat this request for compliance with the protocol for Public Meetings at the beginning of the meeting, will ask any members of the public speaking to please refrain from doing so, and will try to maintain order through the public meeting. If orderly conduct of the meeting becomes unfeasible, those who are willfully interrupting the meeting may be removed. All participants are expected to maintain civility and respect. Disruptive behavior, including personal attacks or profanity, will not be tolerated.
