



## Update on Scofieldtown Rd Recycling Center

Following three public design meetings last fall and winter, the City of Stamford Engineering Bureau developed a plan for the Scofieldtown Park and Yard that would support public uses and City operations. The final design can be viewed at [www.scofieldtownpark.org](http://www.scofieldtownpark.org).

With a design in place, the next step, as required by the CT Department of Energy and Environmental Protection, is to cap the landfill, configuring it to support predetermined end-uses. In preparation of the capping, the Yard was closed last month, removing all of the vegetation, except for some of the perimeter trees. This also necessitated the closing of the recycling facility, which will remain closed until further notice.



The bid for the capping is scheduled to go out on **June 12, 2014**, with anticipation that work will begin this year.

## Paint Recycling

All brands of house paint, stain and varnish can now be recycled, with Connecticut becoming the third state in the U.S. to pass paint stewardship legislation. PaintCare, a Washington, DC-based, non-profit product stewardship organization for the paint industry, is establishing recycling locations throughout the state, mostly at local paint and hardware stores. Here in Stamford, **Keogh's Hardware** on High Ridge Road and **Sherwin Williams** on Hope Street are participating locations.

Accepted items include:

- Interior and exterior paints: latex, acrylic, water-based, alkyd, oil-based, and enamel
- Deck coatings
- Floor paints
- Primers
- Sealers
- Undercoats
- Stains, shellacs, lacquers, varnishes, and urethanes
- Waterproofing concrete/masonry/wood sealers and repellents
- Metal coating and rust preventatives
- Field and lawn paints

Leaking, unlabeled and empty containers are not accepted nor are aerosols (spray cans), solvents, and products intended for industrial or non-architectural use.

**Q: How do I recycle old Propane tanks?**

A: They should be recycled at the Katrina Mygatt Recycling Center, 130 Magee Ave.

**Q: How do I obtain a permit to dump garbage or recycling?**

A: Free dump permits can be obtained by bringing your car registration to the Scale House, 105 Harbor View Ave. If your car is not registered in Stamford, a utility bill in the vehicle owners name is also required along with the vehicle registration. Call (203) 977-4620 with any questions.
